### 10.00 Opening Welcome address and Introduction Title: Presentation of the course programme Abstract: The aim of this introductory session is to give a general overview of the course and to get to know the organizers and participants.

Facilitation PHILIP D. JAFFÉ is Professor at the University of Geneva's Faculty of Psychology and Educational Sciences. He is also the Director of the University Institute Kurt Bösch (IUKB) in Sion, Switzerland, which specializes in Children's rights (www.iukb.ch). Along with Jean Zermatten, he is responsible for the sector Child and youth policy within the Swiss Center of Expertise in Human Rights and serves on its Board. Trained in Geneva, New York and Boston, he worked for several years as a clinical and legal psychologist in Massachusetts' maximum security prison mental health system. After returning to Geneva, in addition to part-time academic duties at the University of Geneva and later on at the IUKB, he continued working in the prison system and developed a private practice as a psychotherapist and a court expert. Areas of interest: children in conflict with the law, child-friendly justice, and the field of Children's rights.

> JEAN ZERMATTEN was President and Dean of the juvenile Court of the Canton of Valais (Switzerland) from 1980 to 2005; he is also the Founder and Director of the International Institute for the Rights of the Child (IDE) in Sion/Switzerland (www.childsrights.org) and has been Lecturer at the University of Fribourg (Arts Faculty, Social Work and Law Faculty). He has initiated and launched the MAS in Children's Rights, in collaboration with the University of Fribourg and the Institut Universitaire Kurt Bösch and various academic DAS and CAS on children's rights issues for professionals. He is used to working in different continents, including in Africa and is Member of the WAN (West Africa Network for children on the move, with the International Social Service). He is Dr h.c. from the University of Fribourg. Member of the UN Committee for the Rights of the Child since 2005, Vice-Chair 2007-11, Chairperson 2011-2013.

> Dr. ROBERTA RUGGIERO holds a Master of Law and a PhD in Promotion and Protection of Children's Rights from the University of Molise, Italy. She is Scientific collaborator at the Children's Rights Unit of the University Institute Kurt Bösch (IUKB) in Sion, Switzerland where she works as coordinator of the Master of Advanced Studies in Children's Rights (http://www.iukb.ch). She is also scientific coordinator of the Summer School "Children at the Heart of Human Rights" taking place from June 16 to July 4, 2014 at the University of Geneva (www.genevasummerschools.ch/courses-2014). She is also senior lecturer at the University of Padua, Italy, at the Faculty of Political Science in a course on Social Policies Dedicated to Childhood. From 2008 to 2013 she had been the scientific coordinator of the European Network of National Observatories on Childhood (ChildONEurope), Istituto degli Innocenti in Florence, Italy. Prior to these positions she worked as researcher at the International Organization for Migration, at the UNICEF-Innocenti Research Centre and as external professor on children's rights at the Faculty of Human and Social Sciences, University of Molise, Italy from 2000 to 2009. Her research interests and publications include children's right in the EU framework of law, ombudspersons for children, implementation of children's rights, child deinstitutionalization, trafficking in human beings and unaccompanied migrant children, child witchcraft allegation.

Title: Background, motivation and main themes of the CRC

Abstract: The lecture will provide an overview of the historical background and main motivation that led to the drafting and adoption of the UN Convention on the rights of the child in 1989. In a second part it will focus on the description of the structure and main statements enshrined by this international treaty.

Lecturer: **KIRSTEN SANDBERG** is a Norwegian jurist and expert on the rights of children. She is Professor of Law at the University of Oslo Faculty of Law, served as Acting Supreme Court Justice in the Supreme Court of Norway 2010–2011, and in 2011 was elected a member of the United Nations Committee on the Rights of the Child as the nominee of the Government of Norway. From 2012 she is also Pro-Dean for Education of the Faculty of Law. She has been a Visiting Fellow at the European University Institute in Florence and the University of Chicago.

- The challenge of Interdisciplinarity: towards a Global Understanding of Children's Rights Title: Abstract: Interdisciplinarity is now an important issue for the development of universities and for scientific research to innovate with and beyond disciplinary boundaries. The challenge set by interdisciplinarity is to realize that the progress of knowledge surely involves disciplinary deepening, but requires at the same time openness to the creativity of knowledge transgressing disciplines. This lecture aims to present the main epistemological issues of interdisciplinarity in general as well as its implementation in the field of children's rights. The following questions will be addressed: how children's rights are to be considered as a complex issue and why this complexity requires all actors (researchers, teachers, students, extra-scientific actors and organizations) to adopt a pluralistic perspective that mobilizes and mixes historical, legal, educational etc. knowledge. On the basis of group work, we will also invite participants to reflect on interdisciplinarity in terms of their disciplinary identity, academic trajectory, experiences, expectations and ambitions.
- Lecturers: FRÉDÉRIC DARBELLAY is Professor at the University Institute Kurt Bösch (IUKB) at Sion in Switzerland, where he is Head of the Inter- and Transdisciplinarity Unit. His research focuses on the study of interdisciplinarity as a creative process of knowledge production between and beyond disciplines. He is author of several publications on the theory and practice of inter- and transdisciplinarity through multiple scientific fields in higher education. Among his main (authored and co-edited) publications are Interdisciplinarité et Transdisciplinarité en Analyse des Discours, Slatkine, 2005; Le Défi de l'Inter- et Transdisciplinarité, PPUR, 2008; A Vision of Transdisciplinarity. Laying Foundationsfor a World Knowledge Dialogue, EPFL Press/CRC Press, 2008; Repenser l'Interdisciplinarité, Slatkine, 2010; Common Knowledge: The Challenge of Transdisciplinarity, EPFL Press/CRC Press, 2011; Au Miroir des Disciplines: Réflexions sur les Pratiques d'Enseignement et de Recherche Inter- et Transdisciplinaires, Peter Lang, 2011; La Circulation des Savoirs: Interdisciplinarité, Concepts Nomades, Analogies, Métaphores, Peter Lang, 2012; L'interdisciplinarité racontée. Chercher hors frontières, vivre l'interculturalité, Peter Lang, 2014. Frédéric Darbellay is a member of the U.S.-based Association for Interdisciplinary Studies (AIS) and the International Network for Interdisciplinarity and Transdisciplinarity (INIT).

**ZOE MOODY** is Professor at the Swiss University of Teacher Education, Valais. She holds a Bachelor of Pre-primary and Primary Education and an Interdisciplinary Master in Children's Rights of the University institute Kurt Bösch and the University of Fribourg and is currently preparing her PhD Thesis at the University of Geneva. Her research and publications lie at the intersection between educational sciences and the field of children's rights, mobilising in an interdisciplinary manner historical and/or "gender" perspectives. She has been awarded the "Best innovation work in the field of human rights" (Humanrights.ch 2010) and a Special Mention of the Veillard Cybulski Jury (International Association of Judges of Youth and Family, 2010).

*Title:* UN Children's rights monitoring mechanisms: the new CRC Communications Procedure

- Abstract: The lecture will present the UN monitoring mechanisms dedicated to children's rights and will focus on the background, material content and procedural particularities of the CRC Optional protocol on individual complaints. The lecturers will also highlight future expectations.
- Lecturer: **RENATE WINTER** is a judge to the Special Court for Sierra Leone and an expert on family law, juvenile justice systems, women's justice issues and child labour. She is a founding member of the International Institute for the Rights of the Child (IDE) which is dedicated to the worldwide training of judicial personnel and dissemination of information on children's rights and former president of the International Association of Youth and Family Court Judges. Winter is furthermore contributor to the Draft Model Law on Juvenile Justice, the UN Manual on Juvenile Justice, and the Draft Model Law on Child Victims & Witness Protection. Throughout the 1990s, Justice Winter chaired numerous international conferences on matters relating to juvenile justice and gender-related justice issues. Winter holds a Law Degree as well as a Master Degree in Interpretation from the University of Vienna.

Lecturer:	<b>PAULO DAVID</b> is working for the Office of the United Nations High Commissioner for Human Rights (OHCHR) since 1995. He was Secretary of the UN Committee on the Rights of the Child until 2005 and thereafter OHCHR's Regional Representative in the Pacific. He is working since 2008 as Chief of Section for the Human Rights Treaties Division in OHCHR and has been in charge, among others, of the treaty body strengthening process. Before joining the UN, Paulo David worked for the media, for the International Federation of the Red Cross and Red Crescent (in Romania and Turkey) and for Defence for Children- International. Paulo David studied international relations-political sciences (Bachelor), international public administration (post-graduate) and holds a PhD in law from the Free University of Amsterdam. He is the author of a number of publications, including "Human Rights in Youth Sports. A critical review of children's rights in competitive sports" London: Routledge (2005).

### Title: Universal Periodic Review

- Abstract: This lecture will commence with the presentation of the Universal Periodic Review (UPR) mechanism and discuss the importance attached to children's rights within the UPR procedure established by the Human Rights Council. The lecture will continue by addressing the issues related to the role of civil society actors in this process and its importance for children rights.
- Lecturer: JENNIFER PHILPOT-NISSEN is the Human Rights Advisor for World Vision International, and has been with the organization since 2004. Originally from the UK, she graduated from Nottingham University with a Masters degree in International Human Rights Law, and then worked for the Office of the High Commissioner for Human Rights for 8 years, working primarily on child rights issues such exploitation and abuse of children, and the involvement of children in armed conflict.

She facilitates the engagement of World Vision offices around the world with the UN human rights mechanisms, particularly the Committee on the Rights of the Child and the Universal Periodic Review. In recent years, this work has increasingly focused on the participation of children to engage at the international level as their own advocates for change, an area of work for which she has a particular passion.

### Title: Special and Individual complaint procedures

- Abstract: This lecture will provide students with an introduction to the 'special and individual complaint procedures' available in the UN monitoring system. The lecturer will also present her own insights on the subject.
- Lecturer: **NEKANE LAVIN** is a Human Rights Officer at the Office of the High Commissioner for Human Rights. She has a background in international human rights law and international criminal law. Before joining OHCHR she served as a Legal Investigator at the UN-backed International Commission against Impunity in Guatemala (CICIG), providing assistance to national prosecutors in prosecuting criminal networks involved in illegal adoptions. Prior to that, she worked as an Investigator at the Office of the Prosecutor of the International Criminal Court (ICC), conducting investigations in the first cases of the Court concerning the commission of war crimes and crimes against humanity in Eastern DRC. Nekane has also conducted human rights monitoring, reporting and advocacy activities in the UN Peace Mission in the DRC (former MONUC). Currently she supports the UN special procedures mandate on the sale of children, child prostitution and child pornography.

#### Title: DCI' role in the monitoring process

- Abstract: This lecture will discuss the importance role played by the NGO's within the UN and CRC monitoring process. The lecture will continue by presenting the specific activity of Defence for Children International in this context.
- Lecturer: ILEANA BELLO is the Executive Director of Defense for Children International (DCI). DCI is an independent non-governmental organization that has been promoting and protecting children's rights for over 30 years. On a regional, national and local level, DCI is active through its associated members and national sections in 47 countries across the globe. All national sections and associated members design their programs according to the specific needs and priorities of the children in their respective countries, focusing on various areas of work, including juvenile justice, child labor, child rights' to education, child participation and children in armed conflict, among others. Located in Geneva, DCI's International Secretariat (IS) is the focal point of DCI as an international movement. The IS focuses mainly on lobbying, research and advocacy work, primarily around the issue of juvenile justice (which is the priority of the movement at international level) as well as carrying out technical assistance and capacity building to its national sections and associated members.

### Title: Looking back at two decades of international child rights advocacy: Paradoxes, asymmetries and the challenges ahead

- The lecture will present the main findings of an interdisciplinary research project (the Abstract: "Living Rights/Translations" project) that aimed to gain insights into the processes of prioritisation in international child rights advocacy. The project – which has studied the practice of selected UN entities and international NGOs since the adoption of the CRC - strived to go beyond received ideas about child rights priorities, which present them as the objective translation of children's realities. The research findings shed light, in particular, on the links between the trajectories of child rights issues and the increasing institutionalization of children's rights.
- Lecturer: MICHELE PORETTI is senior researcher at the Children's Rights Teaching and Research Unit of the University Institute Kurt Bösch (IUKB). He also works as an independent consultant and evaluator for nongovernmental organizations, in Switzerland and abroad. He has an interdisciplinary academic training and a decade-long experience in the humanitarian field, namely within the International Committee of the Red Cross. He has a Master (MA) in Economics and Social Sciences of the University of Fribourg (1992), a Certificate in Evaluation of public policies of the Swiss Graduate School of Public Administration of Lausanne (2008) and an interdisciplinary Master (MAS) in Children's Rights of the IUKB and the University of Fribourg (2011). His research interests are located at the intersection of theory and practice. He studies, in particular, the processes through which child rights-based organizations translate local knowledge into interventions and the paradoxes associated to the institutionalization of children's rights, namely through laws and policies.

### 09.00 Lecture

### Title: Schools of thought in children's rights

Abstract: The lecture aims reflecting on the differences amongst conceptions of children's rights by proposing a heuristic structure which presents the various approaches as 'schools of thought' in children's rights, taking into account key issues on which opinions diverge.

Lecturer: **KARL HANSON** is Professor in Public Law at the Children's Rights Unit, University Institute Kurt Bösch (IUKB) in Sion, Switzerland. He obtained his doctorate in Law from Ghent University, Belgium, where he worked as a Researcher at the Children's Rights Centre and as a Senior Researcher at the Human Rights Centre. His publications and main research interests are in the emerging field of interdisciplinary children's rights studies and include international children's rights advocacy, child labour and working children, juvenile justice and the role of independent national children's rights institutions. He teaches at the IUKB in the Master interdisciplinaire en droits de l'enfant (MIDE). He is also the Programme Director of the Master of Advanced Studies in Children's Rights (MCR) and a member of the Directive Committee of the European Network of Masters in Children's Rights (ENMCR). He is a member of the Scientific Committee of the National Observatory on Childhood in Danger (ONED, France) and an editor of the journal Childhood (Sage).

### Title: Drafting history and general principles of the CRC

- Abstract: The lecture will give insights in the events that took place during and around the drafting process of the CRC, emphasizing the unique role played therein by children's rights' NGOs. The lecturer will also give critical insights into the reasons for and the context in which the Committee on the Rights of the Child adopted four general principles as the guiding principles for interpreting the CRC.
- Lecturer: **NIGEL CANTWELL** is a children's rights consultant based in Geneva, Switzerland, working on children's rights and child protection issues, including juvenile justice, alternative care and inter-country adoption. - Abstract: This lecture on Children and the Internet will address the main current issues in Children's Rights and Internet Safety and provide the international and European legal framework with regard to these issues. **ELIZABETH MILOVIDOV** is an Attorney and Child Rights Advocate. She is an Assistant Professor at the University of Cergy Pontoise Law School, Paris, France, and an Associate Professor at the American Graduate School in Paris. Prior positions include Litigation Attorney in a San Francisco law firm and General Counsel in two French Internet technology companies.

As a parent and lawyer, Elizabeth has shifted her focus from Internet and Business law to Children's Rights Law and Internet Safety. Elizabeth regularly lectures on Internet safety, leads workshops for parents, and blogs for the Family Online Safety Institute. She obtained a PhD in International Relations and Diplomacy (Dissertation: Intercountry Adoptions and the Internet) (American Graduate School, Paris, France) and holds an MBA / M.A. (European University, Paris, France), a J.D. / M.A. in Law and Political Science (University of California, Davis, USA) and a Bachelor's in Economics (University of California, Los Angeles, USA).
